### Countryside Stewardship Facilitation Fund

Last month, the RPA published the latest round of the Countryside Stewardship Facilitation Fund, which gives groups of farmers and landowners in England the opportunity to work together and share knowledge to protect and enhance the local environment, in line with their local Countryside Stewardship priorities. The £2.5 million fund for this round encourages collaboration between farming groups and supports government efforts to improve the environment and create cleaner, greener landscapes. ### Slurry Infrastructure Grant

A further £74 million is being made available to help farmers invest in improved slurry infrastructure to tackle water pollution, improve air quality and make better use of organic nutrients, the government has announced today (21 November 2023).

Applications are now open for the second round of the [Slurry Infrastructure Grant](#) which forms part of a total £200 million being invested in infrastructure and equipment to tackle agricultural pollution from slurry over the agricultural transition period.
