COUNTRYSIDE STEWARDSHIP HIGHER TIER

Countryside stewardship higher tier is now open. Eligible farmers, foresters and land managers who've received pre-application advice and completed any necessary preparatory works will be invited, on a rolling basis, to apply for Countryside Stewardship Higher Tier (CSHT).

This new CSHT offer includes:

- 132 actions and supplements to protect and enhance the environment including new options for watercourse management
- 142 capital items to support delivery of CSHT actions.
- Rolling applications.
- Monthly agreement start dates, rather than a single, annual dates.
- Quarterly payments for CSHT actions and supplements to help cash flow.
- A simpler online application process via the Rural Payments service.

SLURRY STORAGE: SORT IT IN THE SUMMER, BE WINTER READY

As Autumn is now upon us it is important to make sure you have slurry storage that's fit for purpose for when the winter weather comes:

- Calculate your storage requirements using the AHDB slurry wizard: https://ahdb.org.uk/slurry-wizard.
- Making sure all your drains and guttering are fully functional and keeping clean rainwater separate from dirty water can make a significant difference to overall volumes of slurry on your farm.
- Contingency planning even the best laid plans can go awry when the weather is in play; making sure you know what you'll do if you have storage issues or run out of capacity.
- Think longer term do you need to look at covering existing storage? Is your capacity sufficient to cater for expansion or unforeseen circumstances?

To see you through winter, the Silage, Slurry, and Fuel Oil Regulations (SSAFO) require a minimum of 4 months storage capacity, which goes up to 5 months for cattle and sheep, and 6 months for pigs and poultry.

If you are in a Nitrate Vulnerable Zone (NVZ). The environment agency strongly recommends having six months storage to be sure you can make it through with contingency to spare. For more information click here.

IMPROVED TB MAPPING TOOL ibTB


This new mapping tool is designed to give farmers more certainty about disease risks when purchasing cattle.

On 3rd September 2025, an enhancement was made to additionally display animal-level TB risk data for animals in herds in England.

Users can enter an eartag number into the existing search box and this will zoom to the location of the herd in which the animal currently is and details are displayed using a new display box.

In addition to details about the animal, users can also view details of the current herd and previous herd.
